# Sliding Fee Discount Program



## Who is eligible?

Anyone can apply. Eligibility is based on family size and income for those at, or under, 200% Federal Poverty Guidelines.



## What services qualify for a discount at Full Circle Health?

Services under the Sliding Fee Discount Program include:

- Medical
- Behavioral
- Dental referrals
- X-Ray
- Pathology
- OB/GYN
- Lab tests
- Most medications through Full Circle Health pharmacy



## How do participants pay?

Patients who qualify will pay determined by their payment class. (See back panel for more details.)

Payments can be made by phone, in our office, through your Patient Portal, or by visiting our website.



## How to apply:

Ask for and complete a paper application at any Full Circle Health clinic, or submit or print an application from our website.

Required documents to bring with you to submit your application:

- Most recent tax-return documents
- W-2 form (if applicable)
- One month of pay stubs (if applicable)
- One unemployment stub (if applicable)
- Any denial notices from other assistance programs



## How will I know if my application is approved?

If eligibility is approved, you will receive a letter and sliding fee card in the mail. The patient's eligibility will be in effect for one year from the application date. Any charge incurred at Full Circle Health during the three months prior to the approval date will be adjusted.
